Amendment to the By-Laws (Regarding Membership Fees)

## PREAMBLE

- 1. The By-Law for Clearbrook Tudor Village Condominium Association No. 18-B, Inc. (hereafter, the "Association"), and as subsequently amended (collectively, the "By-Laws"), were originally recorded in the Middlesex County Clerk's Office as "Exhibit "E" to the Association's Master Deed dated January 19, 1990. The Master Deed was recorded in the Middlesex County Clerk's Office on January 22, 1990 in Dccd Book 3833 starting at Page 1.
- The Association's Board of Directors (hereinafter, the "Board") has, as provide in Section 7 thereof, reached an agreement as to a change to be made in the Membership Fee imposed in ARTICLE VI, SECTION 7 of the By-Laws.

## NOW, THEREFORE, BE IT RESOLVED, this \_13\_ day of October 2020, as follows:

- The Membership Fee imposed upon a Unit Owner, upon acquisition of title to a Unit, under ARTICLE VI, Section 7 of the By-Laws, of the Association shall be nine (9) times the amount of the most recent monthly common expense assessment for that Unit.
- Except as expressly set fort in this Amendment (and as previously properly amended), the By-Laws of the Association will not be otherwise deemed modified.
- C. This Amendment to the By-Laws will be effective immediately upon its recordation in the Middlesex County Clerk's Office. The Association Recording Secretary is authorized to record this Amendment with the Middlesex County Clerk's Office immediately following the adoption of same.
